I. CALL TO ORDER

- A. The meeting was opened by a moment of silence followed by the Pledge of Allegiance led by Mayor Gibbons.

- B. On behalf of City Council, Mayor Gibbons asked everyone to keep the family that lost a loved one in a pedestrian accident on Monday, July 15 in their thoughts and prayers during this difficult time.

COMMENDED; CITY

STAFF: C. Mr. Brian Moore, Executive Director, Caldwell County Chamber of Commerce, and Ms. Becky Warren, Manager of Marketing and Events, presented a framed certificate of appreciation to Ken Hair, Fire Chief, Kaylynn Horn, Economic Development Director, Jared Wright, Public Works Director, and Kenny Story, Recreation Director for all of their Staff's hard work during the successful 18th Annual Blackberry Festival held July 11-13 in downtown Lenoir.

On behalf of City Council, Mayor Gibbons thanked all City Departments along with the Chamber of Commerce Staff and the numerous volunteers that assisted with the festival. Mayor Gibbons stated it was a great event which was attended by people from all across the country.

Mayor Pro-Tem Ben Willis also thanked the Chamber of Commerce Staff for all of their assistance over the past several months in preparing for this popular event.

SPECIAL RECOGNITION; FIREFIGHTER OF THE YEAR & POLICE OFFICER OF THE YEAR, AMERICAN LEGION POST 29:

- C. Mr. Irv Eurto, Post 29 American Legion, stated he was pleased to present these awards and to express the American Legion's gratitude not only to these individuals for their selfless service, but also to the Departments for their general excellence and all they do to make the community a safer place. Mr.

Eurto stated the Department Directors were asked to select someone that met the criteria for the award.

First Vice-Commander Henry Smith announced the Firefighter of the Year for the City of Lenoir is Jason Hines. Chief Ken Hair accepted the award on behalf of Mr. Hines who was unable to attend the meeting and stated the Fire Department is honored and privileged to have Mr. Hines as a member. He remarked that Mr. Hines was an educator for seventeen years and currently volunteers at Sawmills Elementary School. Chief Hair further shared that Mr. Hines also serves as the Chaplain for the Department.

Next, Commander Smith presented the Police Officer of the Year Award to Sergeant John Howard. Police Chief Brent Phelps explained it was tough to select just one individual, but stated John Howard was chosen for his extensive work regarding an opioid case which resulted in seven people being charged for possession of drugs and sentenced to serve time in prison. Chief Phelps stated he was proud of Mr. Howard's work for the Police Department and the community.

Mr. Eurto reported the Caldwell County Emergency Medical Technician (EMT) will be recognized at a later date.

On behalf of City Council, Mayor Gibbons expressed appreciation to Sergeant Howard and Mr. Hines for all they do for the citizens of Lenoir and Caldwell County. Mayor Gibbons also thanked American Legion Post 29 for their service to the community.

II. MATTERS SCHEDULED FOR PUBLIC HEARINGS

REZONING REQUEST; SUMMIT PLACE SW:

- A. A public hearing was held to consider a rezoning request for 13 lots located on Summit Place from R-15 (Low Density Single Family) to R-12 (Medium Density Single Family), to facilitate a minor subdivision and house construction at 1248 Norwood Street SW without creating a "spot zone," based on the following Consistency Statement: The proposed zoning map amendment is consistent with the adopted Comprehensive Plan because it establishes zoning that is more consistent with the adopted future land use map designating the area to remain "medium density residential" and better matches the existing development pattern. This will ensure fair and efficient growth, reduce non-conformities, and establish sensible, straightforward zoning standards. The proposed amendment is reasonable and in the public interest because it promotes infill development at appropriate densities, making more efficient use of the City's existing infrastructure investments while creating opportunities for affordable housing for people in all stages of life.

Mayor Gibbons opened the public hearing to receive public comments regarding the rezoning request.

Planning Director Jenny Wheelock reviewed a power point presentation outlining the specifics of the rezoning request.

A copy of the power point which includes a map is hereby incorporated into these minutes by reference. (Refer to pages 434-440).

Director Wheelock reviewed the map of the thirteen lots on Summit Place to be rezoned from R-15 to R-12. She pointed out the applicant's property is labeled as 13 or (+14 lots if subdivided) and is 0.57 acres. Director Wheelock explained that only four of the existing 13 lots conform to the minimum lot size of 15,000 square feet for the current R-15 zoning which are identified as lots 8, 9, and 10 plus the applicant's as shown on the map). She further stated the side setbacks are 15-feet for R-15 zoning and are 12-feet for R-12 zoning.

Director Wheelock clarified by rezoning the property to R-12, the minimum lot size would be reduced from 15,000 square feet to 12,000 square feet and it would allow the applicant's property to be divided into two buildable lots. This step would also increase the total number of lots to 14, of which 8 would be conforming. It was noted that 6 lots or 43% would remain non-conforming for being below the minimum lot size statutory requirement. Also, Director Wheelock pointed out that even if the block was rezoned to R-6, the most dense residential district would result in 3 lots (labeled as 3, 4 and 5 on the map) as still being under the minimum lot size of 6,000 square feet for that district.

Director Wheelock reported Staff is recommending R-12 rezoning due to it being the most similar to R-15 in terms of permitted uses, and it would accommodate the proposed lot split and resulting infill development without introducing major changes to the neighborhood.

In addition, Director Wheelock stated the applicant chose to split the lot so all new home construction would face Norwood Street following a review of his option to either front the homes on Norwood Street or Summit Place.

There being no further public participation, Mayor Gibbons closed the public hearing and asked Council for action.

Councilmember Perdue referred to housing as Lenoir's greatest need and moved to approve the rezoning request as submitted.

Upon the motion by Councilmember Perdue, Council voted 5 to 0 to approve the rezoning request for property located on Summit Place as described above and as recommended by City Staff.

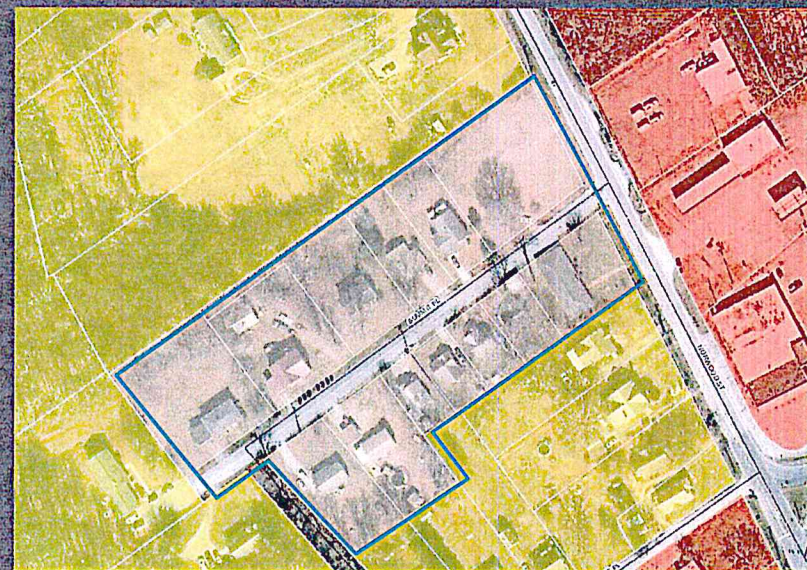
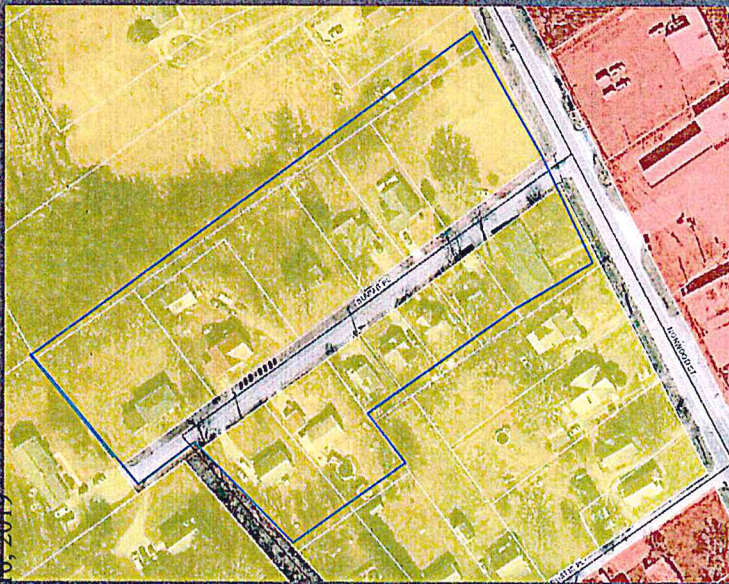

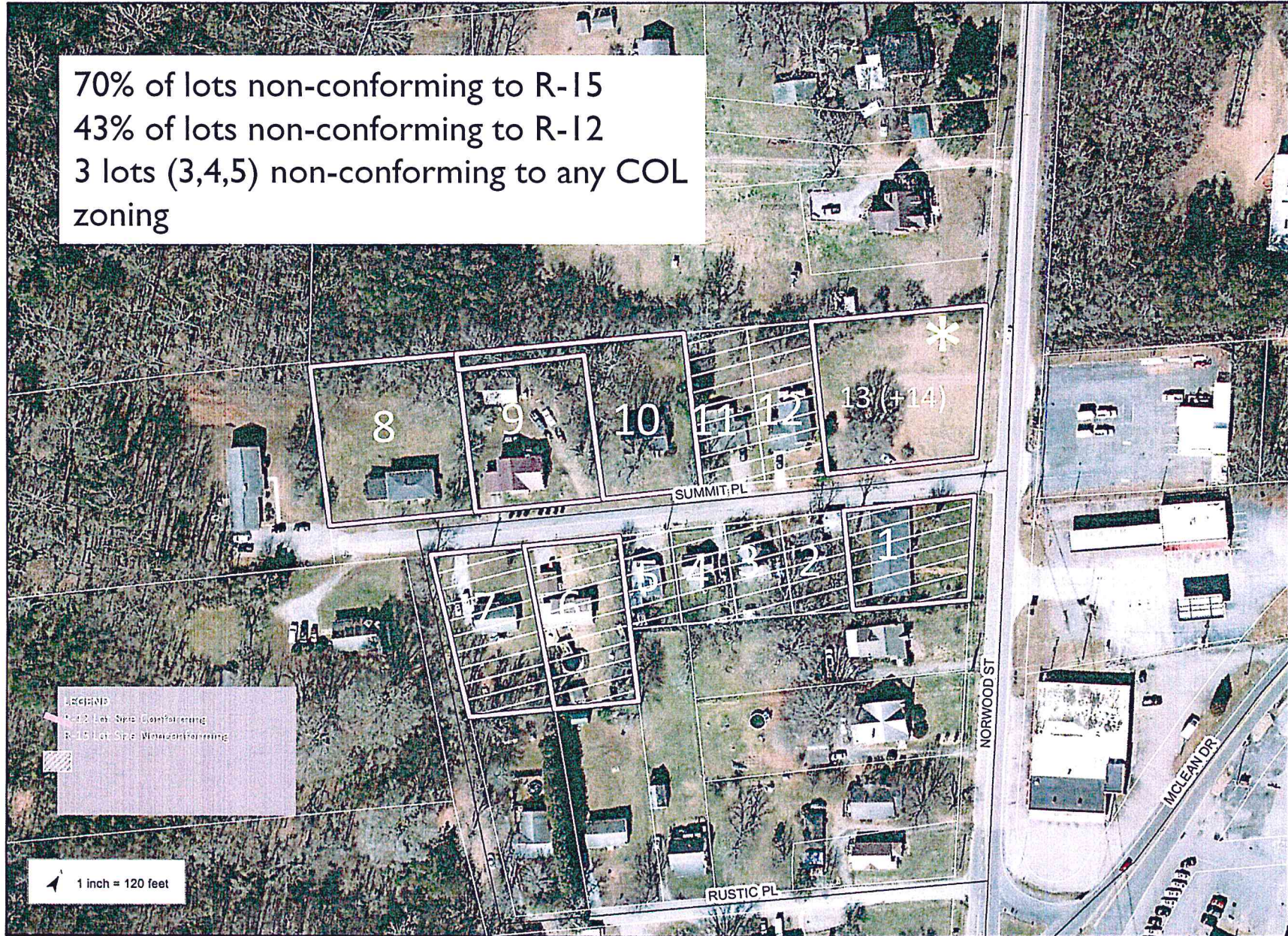
▶ **R-12 Medium Density Single Family**

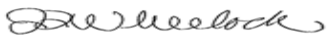

§ 160A-269. Negotiated offer, advertisement, and upset bids.

A city may receive, solicit, or negotiate an offer to purchase property and advertise it for upset bids. When an offer is made and the council proposes to accept it, the council shall require the offeror to deposit five percent (5%) of his bid with the city clerk, and shall publish a notice of the offer. The notice shall contain a general description of the property, the amount and terms of the offer, and a notice that within 10 days any person may raise the bid by not less than ten percent (10%) of the first one thousand dollars (\$1,000) and five percent (5%) of the remainder. When a bid is raised, the bidder shall deposit with the city clerk five percent (5%) of the increased bid, and the clerk shall readvertise the offer at the increased bid. This procedure shall be repeated until no further qualifying upset bids are received, at which time the council may accept the offer and sell the property to the highest bidder. The council may at any time reject any and all offers. (1971, c. 698, s. 1; 1979, 2nd Sess., c. 1247, s. 25.)

Resolution of Intent to Close Steele Street between College Avenue and Harper Avenue.

II. Background Information:

Steele Street was originally a 30-ft wide private alleyway to serve the two adjacent properties, with 15 ft. being reserved from each property. At some point in the past, the City of Lenoir took over maintenance responsibilities and has considered Steele Street a publicly opened street.

The two adjacent owners are in agreement with the street closure, which would resume the use of Steele Street as a private access driveway to serve the two properties. Ultimately, the City's plans to convert Harper Avenue to carry two-way traffic would have required the closing of the connection from Steele St. to Harper Ave, in order to accommodate a safe trail crossing location and re-alignment of West Avenue into Harper Avenue. (See map, attached – only two properties are impacted by this closure, and the current property lines on the tax maps already go to the centerline of this street.)

In accordance with NCGS 160A-299, the attached resolution of intent, which calls for a Public Hearing to be held on September 17, 2019, will be advertised for 4 consecutive weeks in the Lenoir News-Topic. A copy of the resolution will be sent to each adjacent property owner, and notice of the public hearing will also be posted on the subject properties.

This street closure facilitates the long-term goals for City infrastructure as well as private redevelopment in the area immediately adjacent to the Downtown and the planned Rail Trail/OVT greenway project.

III. Staff Recommendation:

Adoption of the attached resolution, to cause the Clerk to advertise for the public hearing for the street closure consistent with NCGS 160A-299.
